Every four years.....

Every four years parishioners in Beckingham have the right to vote for their Parish Councillors.

Every four years parishioners in Beckingham have the right to stand as a new Parish Councillor for four years (subject to certain conditions being met).

You can exercise these rights in the forthcoming Local Elections to be held on 4th May

Key Election Dates

- **16 March** time from which nominations for North Kesteven can start to be submitted.
- 4pm Tuesday 4 April deadline to submit nominations /deadline to withdraw as a candidate
- Monday 17 April midnight deadline to apply to register to vote
- Tuesday 18 April 5pm deadline to apply for new postal vote and proxy postal votes and to make changes to existing postal or proxy votes
- Tues 26 April 5pm Deadline to Apply for a Voter Authority Certificate
- Thursday 4 May 7am-10pm Polling Day (where elections are contested)
- Friday 5 May expected count of votes

Use it—don't loose it

Rush to get historic public rights of way registered is underway

The Deregulation Act 2015 received royal assent on 26 March 2015. A small but an important part of the act in Schedule 7 concerns public rights of way.

On 1 January 2026 the government intends to close the definitive maps to the claim of historic paths which existed before 1949 (section 53 of the Countryside and Rights of Way Act 2000 (CROW Act)), with the aim of providing certainty to landowners about what highways and other rights exist on their land. Earlier this year DEFRA said they may drop the 2026 deadline, but it has not introduced legislation to do it.

Organisations such as the Open Spaces Society, The Ramblers Association have long-standing campaigns to get as many pre-1949 public rights of way identified before the deadline. In 2020 it was estimated that there was over 49,000 miles of missing footpaths and other rights of way that need to be added to the definitive maps.

In Lincolnshire it was estimated that there could be 1,500 miles missing. Signs that there might be an historic right of way could be a footpath or bridleway coming to an end at the parish boundary, at a field boundary or when it meets a road. The process of putting the definitive map together after 1949 relied on local parishes having records, or local memory of past routes which may have been lost (after the impact of the First and Second World Wars) and local landowners (who may have been councillors at the time) being willing to agree to put information forward to the County Councils doing the survey. Some parish councils were more willing than others.

Volunteers and local groups are checking historic maps and documents to identify the public rights of way that have not been added to Lincolnshire

Voting in April and May 4th 2023 Both District and Parish Council Elections May 4th

Voter ID: Despite widespread objections from the Electoral Commission and councillors, the Government has decided to require photo identification at the polling stations. I have argued against this at all levels, and continue meetings with the ministers this week to try and £3m County-funded extra 59 PCSO's in Lincolnshire some improve how it is implemented. Fraud in person is very rare, whereas significant fraud has been found in the postal votes, so this new requirement is more of a barrier than a help. Nevertheless, we need to either get a postal vote or bring photo ID on the day. A bus pass, photo driving licence or a passport will be OK.

Supporting our Neighbourhood Policing PCSO's to reduce from 91-50

We wanted PCSO's because they are neighbourhood based, with the purpose of heading off incidents and avoiding criminal actions. PCSO's build trust and relationships and give community reassurance. They deal with victims of anti-social behaviour, help guide and keep young people in schools and clubs on the straight and narrow, despite pressures. As we know, if smaller crimes are not dealt with, they develop into bigger crimes. The PCSO's also attend road traffic accidents to manage the traffic, and support vulnerable people to help avoid scams, and in cases of mental health concern.

Much of this preventative work does not register as incidents, but is nevertheless vital to our communities. Some were recruited last October, have just completed their training and are now facing redundancy.

More police are being recruited, but they do not replace the PCSO's. PCSO's are committed to our local areas. Lack of PCSO's and their neighbourhood policing leads to a disconnect with communities, making any police response much less effective.

I was instrumental in the introduction of an additional years ago. PCSO's are to Policing what care is to the NHS essential prevention of crime. PCSO Sarah Lingard was first appointed in 2003, twenty years ago and does a great job. https://thelincolnite.co.uk/2023/01/celebrating-20years-of-pcsos-in-lincolnshire/

Photo ID needed to vote in elections on May 4

Anyone wishing to vote in person at the local elections to be held on May 4, to elect District and parish or town councillors, will need to take with them a form of photo identification. This is a change being introduced by the UK Government for all of England and will apply across all of Lincolnshire's local district and parish elections.

Accepted forms of photo ID

You can use any of the following accepted forms of photo ID when voting at a polling sta-

International travel

Passport issued by the UK, any of the Channel Islands, the Isle of Man, a British Overseas Territory, an EEA state or a Commonwealth country

Driving and Parking

Driving licence issued by the UK, any of the Channel Islands, the Isle of Man, or an EEA state (this includes a provisional driving licence)

A Blue Badge

Local travel

Older Person's Bus Pass

Disabled Person's Bus Pass

Oyster 60+ Card

Freedom Pass

Scottish National Entitlement Card

60 and Over Welsh Concessionary Travel Card

Disabled Person's Welsh Concessionary Travel Card

Senior SmartPass issued in Northern Ireland

Registered Blind SmartPass or Blind Person's SmartPass issued in Northern Ireland

War Disablement SmartPass issued in Northern Ireland

60+ SmartPass issued in Northern Ireland

Half Fare SmartPass issued in Northern Ireland

Proof of age

Identity card bearing the Proof of Age Standards Scheme hologram (a PASS card)

Other government issued documents

Biometric immigration document

Ministry of Defence Form 90 (Defence Identity Card)

National identity card issued by an EEA state

Electoral Identity Card issued in Northern Ireland

Voter Authority Certificate

Anonymous Elector's Document

You will only need to show one form of photo ID. It needs to be the original version and not a photocopy.

Out of date photo ID

You can still use your photo ID if it's out of date, as long as it looks like you.

The name on your ID should be the same name you used to register to vote.
